WS_FTP Professional Accessibility

WS_FTP Professional is compatible with all items in the Voluntary Product Accessibility Template, or VPAT™, with the exception of a small number of features. VPAT is a standardized form created by the Information Technology Industry Council showing how a given software product meets requirements laid out in Section 508 of the Rehabilitation Act of 1973. VPAT assists Federal contracting officials and other buyers in making preliminary assessments regarding the availability of commercial "Electronic and Information Technology" products and services with features that support accessibility. The following tables list the VPAT sections relevant to WS_FTP Pro, and describe how the product fulfills them. In cases where there is an exception in 508 support with regard to a specific feature, those exceptions are listed.
